# YTV'S FALL GETAWAY GIVEAWAY CONTEST RULES

THE YTV'S FALL GETAWAY GIVEAWAY CONTEST (THE "CONTEST") WILL BE CONDUCTED IN CANADA ONLY (EXCLUDING QUÉBEC) AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE OR OLDER] AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

### 1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
  - (a) be a legal resident of Canada (excluding the province of Québec);
  - (b) be of the age of majority in their province or territory of residence or older at the time of entry; and
  - (c) be legally able to travel to Punta Cana, Dominican Republic and have any and all necessary documentation that may be required for presentation to Canadian and/or International customs and airport personnel.
- 1.2 The following people are not eligible to enter the Contest:
  - (a) Employees of Corus Sales Inc. its parent, affiliates, subsidiaries, related companies, successors and assigns (collectively "Corus");
  - (b) Employees of Premier Worldwide Marketing its affiliates, subsidiaries, related companies, successors and assigns (collectively, "**Premier**", together with Corus, the "**Sponsors**");
  - (c) Employees of Nickelodeon Hotels & Resorts its affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies;
  - (d) Employees of Ripley's Aquarium of Canada LP its affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies;
  - (e) Employees of Bayard Presse Canada Inc. its affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies;
  - (f) Any person who has been confirmed as a winner of two (2) Corus administered contests within six (6) months preceding the Contest start date indicated below; and
  - (g) The household members of any of the parties listed in Section (a) to (f) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the

right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. CONTEST PERIOD. The Contest begins at 9:00a.m. Eastern Time ("ET") on October 1, 2021 and ends at 11:59p.m. ET on October 31, 2021 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

### 3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. Enter by tuning into YTV during the Contest Period and watch for the daily clue (the "Daily Clue"). Then go online to <a href="https://www.ytv.com/fallgetaway">www.ytv.com/fallgetaway</a> and enter by submitting the correct Daily Clue in your entry form in order to be eligible. No entries will be accepted by any other means.
- 3.2 Limit of one (1) entry per person per 24-hour period. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries, become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.

## 4. PRIZES.

- 4.1 **Grand Prize.** There is one (1) grand prize (the "**Grand Prize**") available to be won by the Grand Prize winner (the "**Grand Prize Winner**") consisting of: a trip for two adults (2) and two children (2) (children must be 12 and under) to Punta Cana, Dominican Republic (the "**Destination**") which shall include:
  - (a) Round-trip economy airfare for the Grand Prize Winner and three (3) guests (collectively, the "Guests", each a "Guest") leaving together from the same gateway, on the same itinerary, from a major Canadian airport located near the Winner's home, as determined by the Sponsors in their sole discretion, to the Destination;
  - (b) Seven (7) nights hotel accommodation in a swim up suite at the Nickelodeon Resort in the Destination or such other venue to be selected by the Sponsors in their sole discretion for the Grand Prize Winner and Guests based on quadruple occupancy unless otherwise indicated; and
  - (c) An all-inclusive meal plan for the Grand Prize Winner and Guests (some exclusions apply).

- 4.2 The Grand Prize has an approximate value of twelve thousand Canadian dollars (CDN \$12,000). Actual value of Grand Prize will depend on departure city.
- 4.3 **Secondary Prize.** There is one (1) secondary prize (the "**Secondary Prize**") available to be won by the Secondary Prize winner (the "**Secondary Prize Winner**"), which consists of a "Virtual Tour from Ripley's Aquarium of Canada" (which includes a virtual sea turtle feeding).
- 4.4 The Secondary Prize has an approximate retail two hundred Canadian dollars (CDN \$200).
- 4.5 **Finalist Prize.** There is one (1) finalist prize (the "**Finalist Prize**") available to be won by the Finalist Prize winner (the "**Finalist Prize Winner**"), which consists of: a twelve (12) month subscription to OWL Magazine.
- 4.6 The Finalist Prize has an approximate retail value fifty-two Canadian dollars (CDN \$52).
- 4.7 Grand Prize, Secondary Prize and Finalist Prize are hereafter collectively referred to as "**Prize**" or "**Prizes**". Grand Prize Winner, Secondary Prize Winner and Finalist Prize Winner are hereafter collectively referred to as a "**Winner**" or "**Winners**".
- 4.8 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.9 The Sponsors and/or the Sponsors' representatives will contact the Winners to coordinate the provision of the Prizes within thirty (30) days once such Winners have been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

# 5. PRIZE CONDITIONS.

- 5.1 All bookings and/or reservations are subject to availability at time of booking.
- 5.2 Grand Prize Winner and Guests must be able to travel before November 14, 2022. Blackout dates for the Grand Prize applies, which includes: (i) December 23, 2021 to January 2,2022; (ii) February 19, 2022 to February 22, 2022; (iii) April 10, 2022 to April 17, 2022; and (iv) July 1, 2022 to July 5, 2022. Should Grand Prize Winner and Guests be unable to travel on the dates and times designated by the Sponsors, the Grand Prize will be forfeited and awarded to an alternate Grand Prize winner.
- 5.3 Secondary Prize Winner must be able to participate in the Secondary Prize on or before May 1, 2022. Secondary Prize Winner must be available to participate in the Secondary Prize at the following days and times: (i) Monday, Wednesday or Friday at 1:30p.m.; or (ii) Tuesday or Thursday at 1:00p.m. Should the Secondary Prize Winner be unable to participate on the dates and times designated by the Sponsor's, the Secondary Prize will be forfeited and awarded to an alternate Secondary Prize winner.
- 5.4 Should Winners and/or Guests be unable to travel and/or participate on the dates and times designated by the Sponsors', the Prize will be forfeited and awarded to an alternate winner.
- 5.5 Grand Prize Winner and Grand Prize Guests will be responsible for any other expense not explicitly included in the Prize including but not limited to transportation to and from originating airport, transportation to and from airport in the Destination to the hotel, travel and medical insurance, travel documentation, any required medical testing required by either country,

additional accommodation fees incurred due to COVID-19 related quarantine requirements, airport improvement fees, bag check fees, taxes, gratuities, telephone calls, and in-room charges. Grand Prize Winner may be required to present a valid major credit card upon check-in at the hotel to cover any expenses over and above the standard room charge.

- 5.6 Guests must: (i) be legally able to travel to Dominican Republic and have any and all necessary documentation as may be required for presentation to Canadian and/or International customs and airport personnel; and (ii) comply with the Contest Rules and sign and return the Release (described below).
- 5.7 Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.
- 5.8 Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

# 6. WINNER SELECTION.

- 6.1 Three (3) Winners shall be selected as follows:
  - (a) On or about November 5, 2021 in Toronto, Ontario, three (3) entrants will be selected by a random draw from all eligible entries received during the Contest Period. Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Winner, each selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and to sign and return the Release (described below).
  - (b) EACH SELECTED ENTRANT WILL BE NOTIFIED BY E-MAIL NO LATER THAN NOVEMBER 5, 2021 AT 2:00P.M. AND MUST RESPOND WITHIN FIVE (5) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
  - (c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.
- 7. RELEASE. Potential Winners and Guests will be required to execute a legal agreement and release

("Release") that confirms each potential Winner's and Guest's: (i) eligibility for the Contest and compliance with these Contest Rules; (ii) acceptance of the Prize as offered; (iii) release of each of the Sponsors and each of their employees, directors, officers, suppliers, agents, sponsors, administrators, licensees, representatives, advertising, media buying and promotional agencies (collectively, the "Releasees") from any and all liability for any loss, harm, damages, cost or expense arising out of participation in the Contest, participation in any Contest-related activity or the acceptance, use, or misuse of any Prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom; and (iv) grant to the Sponsors of the unrestricted right, in the Sponsors' collective or individual discretion, to produce, reproduce, display, publish, convert, post, serve, broadcast, exhibit, distribute, adapt and otherwise use or re-use the Winner's and Guest's name, statements, image, likeness, voice and biography, in any and all media now known or hereafter devised, in connection with the Contest and the promotion and exploitation thereof. The executed Release must be returned within five (5) business days of the date indicated on the accompanying letter of notification or the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.

- **8. INDEMNIFICATION BY ENTRANT.** By entering the Contest, each entrant releases, indemnifies and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach of the Contest Rules. Each entrant agrees to fully indemnify the Releasees from any and all claims made by third parties relating to the entrant's participation in the Contest, without limitation.
- 9. LIMITATION OF LIABILITY. The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Microsite.
- 10. CONDUCT. By participating in the Contest, each entrant is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at the Contest Microsite and made available throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Sponsors which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest and/or the Contest Microsite or any related promotional website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Corus property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass the Sponsors or any other person. - 11.2 By opting-in online you consent to Corus using your Personal Information to contact you to promote draws and contests similar to the Contest, promote opportunities to subscribe to newsletters or promotional clubs, and notify you about related products or services. - **12. - **13. TERMINATION.** The Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
- 14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
