YTV'S DRAGONS: THE NINE REALMS WATCH AND WIN RULES

THE YTV'S DRAGONS: THE NINE REALMS WATCH AND WIN CONTEST (THE "CONTEST") WILL BE CONDUCTED IN CANADA (EXCLUDING QUÉBEC) AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THEIR PROVINCE OR TERRITORY OF RESIDENCE OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. 1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
 - (a) be a legal resident of Canada (excluding the province of Québec);
 - (b) be of the age of majority in their province or territory of residence or older at the time of entry; and
 - (c) submit the correct Daily Clue (as defined in Section 3.1(a) below) on their entry form on the Contest Microsite (as defined in Section 3.1(b) below).
- 1.2 The following people are not eligible to enter the Contest:

2. CONTEST PERIOD. The Contest begins at 11:00 a.m. Eastern Time ("ET") on October 24, 2022 and ends at 11:59 p.m. ET on November 13, 2022 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - (a) To enter, tune into YTV during the Contest Period and watch for the daily clue (the "**Daily Clue**"); and
 - (b) complete and submit the entry form located at <u>www.ytv.com/dragons</u> (the "**Contest Microsite**") and include the correct Daily Clue in your entry form.
- 3.2 Limit of one (1) entry per person, per e-mail address, per day. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of Corus and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. - 4.4 Prize will be distributed within thirty (30) days after Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- 5.1 Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of Corus.
